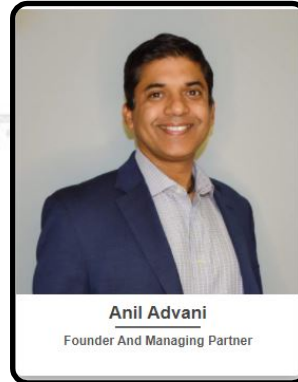

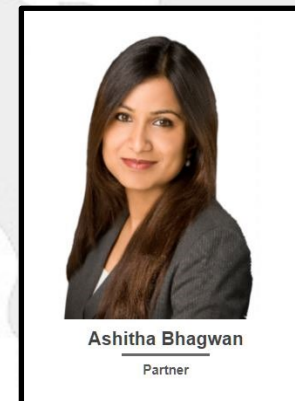

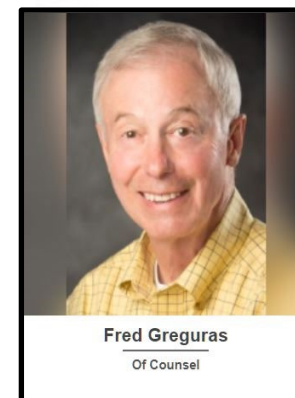

Paanini, dba Jiffy.Ai, has raised \$18 million in Series A funding for product development and expansion into new markets around the world. JIFFY.ai uses robotic process automation, machine learning and artificial intelligence to help companies automate tasks that are usually performed manually.



CloudEnablers, a B2B Enterprise software company that provides SAAS / Hybrid platform to accelerate cloud adoption, had their cloud operation and governance platform adopted by CoreStack. Corestack announced an \$8.5 million Series A investment round this year, with total funding to date of \$13 million.



After raising \$55 million in October 2018 at a \$500 million valuation, business software marketplace G2 Crowd made its first-ever acquisition to bring more features to its platform. It acquired Siftery, who raised a seed round of \$4.1 million from a group of notable investors Founders Fund, Felicis and Venrock.



Tax filing and investment startup ClearTax has raised \$50 million (approximately Rs 370 crore) as a part of its Series B round of financing from Hong Kong-based Composite Capital. Cleartax also said existing investors would participate in the round as well, taking the total funding to Rs 400 crore.



Netradyne, a leader in artificial intelligence technology focusing on driver and fleet safety, had a \$21 million financing in new Series B funding. Investors in this round include Reliance Industries Limited, who previously invested \$16 million during Netradyne's Series A round of funding, M12, Microsoft's corporate venture arm, and Point72 Ventures.

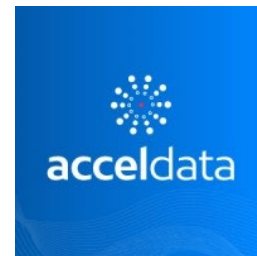
